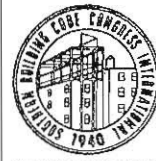

### PERMIT FEES

Total Valuation	Fee
\$100.00 and less	No fee, unless inspection required, in which case a \$15.00 fee for each inspection shall be charged.
\$101.00 to \$1000.00	\$5.00 up to \$1000.00.
\$1001.00 to \$50,000.00	\$15.00 for first \$1,000.00 plus \$5.00 for each additional thousand or fraction thereof, to and including \$50,000.00.
\$50,001.00 to \$100,000.00	\$260.00 for the first \$50,000.00 plus \$4.00 for each additional thousand or fraction thereof, to and including \$100,000.00.
\$100,001.00 to \$500,000.00	\$460.00 for the first \$100,000.00 plus \$3.00 for each additional thousand or fraction thereof, to and including \$500,000.00.
\$500,001.00 and up	\$1,660.00 for the first \$500,000.00 plus \$2.00 for each additional thousand or fraction thereof.

### B102 MOVING FEE

For the moving of any building or structure, the fee shall be \$100.00.

### B103 DEMOLITION FEE

For the demolition of any building or structures, the fee shall be:  
0 - 100,000 cu. ft. \$50.00  
100,000 cu. ft. and over \$0.50/1,000 cu. ft.

### B104 PENALTIES

Where work for which a permit is required by this Code is started or proceeded prior to obtaining said permit, the fees herein specified shall be doubled, but the payment of such double fee shall not relieve any persons from fully complying with the requirements of this Code in the execution of the work nor from any other penalties prescribed herein.

### B105 PLAN-CHECKING FEES

When the valuation of the proposed construction exceeds \$1,000.00 and a plan is required to be submitted by 104.2, a plan-checking fee shall be paid to the Building Official at the time of submitting plans and specifications for checking. Said plan-checking fee shall be equal to one-half of the building permit fee as set forth in 103.7.4. Such plan-checking fee is in addition to the building permit fee.
